# 2017 WVC CHAMPIONSHIPS TOURNAMENT

2017 Wisconsin Volleyball Conference State Championships Tournament Format Friday, April 7 - Saturday, April 8

All Pool Play matches will start at or after the designated start time. Playoff Matches may begin ahead of schedule.

#### Warm-ups:

Pool Rounds 1-2 Friday, 5-6 Saturday and Playoffs: 10 minutes - suggested 3 min ball handling, 6 min shared hitting, 1 min serving Pool Rounds 3-4 Friday (Playoff option unless first match of the day): 6 minutes - suggested 5 min shared hitting, 1 min serving

Referees (R1's) are provided for each match. Teams must provide an R2, 2 line judges, and 2 scorekeepers for all pool play and Quarterfinal and Consolation Matches.

Note: Many teams officiate "outside" of your division. These matches are shaded gray on both the schedule grid and playoff bracket.

#### **TOURNAMENT FORMAT - MEN'S DIVISION 1**

The Men's Division 1 Tournament for each division will consist of the remainder of the regular season double round-robin schedule. These "pool play" games and playoff matches are best 2 of 3 sets to 25, with the third set to 15. No point cap in any sets. The third set is played only if it is a deciding set. After pool play the regular season champion will be determined and all teams will then be pre-seeded into an opening round quarterfinal playoff match based on their regular season (pool play) finish, with the exception of the first place team who advances to the MEN'S DIVISION 1 SEMIFINALS. The following tiebreaker criteria will be used for seeding teams into the playoffs:

- (a) Overall Season Match Record
- (b) Head to Head Match Record
- (c) Set Percentage (sets won/total sets played)
- (d) Coin Flip

Opening round playoff round winners will advance to the CHAMPIONSHIP PLAYOFFS while the Quarterfinals losers will advance to the CONSOLATION PLAYOFFS. Most losing teams will officiate the next match on their court. The MEN'S DIVISION 1 WVC CHAMPIONSHIP MATCH will be played at 5:45 pm on Court 3

#### **TOURNAMENT FORMAT - WOMEN'S DIVISION 1**

The Women's Division 1 Tournament will consist of three 4-team pools and will play standard Pool Play format against teams in your pool. All pool play and playoff matches are best 2 of 3 sets to 25, with the third set to 15. No point cap in any sets. The third set is played only if it is a deciding set. After the completion of Pool Play, the top two teams in each pool will advance to the WOMEN'S CHAMPIONSHIP PLAYOFFS while the third and fourth place teams in each pool will advance to the WOMEN'S CONSOLATION PLAYOFFS. Most losing teams will officiate the next match on their court. The WOMEN'S DIVISION 1 WVC CHAMPIONSHIP MATCH will be played at 5:45 pm on Court 2.

The following tiebreaker criteria will be used for seeding teams into the playoffs:

- (a) Overall Match Record
- (b) Head to Head Match Record
- (c) Set Percentage (sets won/total sets played)
- (d) Point Percentage (points scored/points opponents scored)
- (e) Coin Flip

All pool play and playoff matches are best 2 of 3 sets to 25, with the third set to 15. No point cap in any sets. The third set is played only if it is a deciding set. After the completion of Pool Play, the first place team in each pool will advance to the WOMEN'S CHAMPIONSHIP PLAYOFFS while the second and third place teams in each pool will advance to the MEN'S/WOMEN'S D2 CHALLENGE MATCHES on Saturday morning. CHALLENGE MATCH WINNERS advance to the MEN'S/WOMEN'S CHAMPIONSHIP PLAYOFFS while the losing teams advance to the MEN'S/WOMEN'S CONSOLATION PLAYOFFS. Most losing teams in the playoffs will officiate the next match on their court. The MEN'S/WOMEN'S D2 WVC CHAMPIONSHIP MATCHES will be played at 4:30 pm on Court 2 (Women) and Court 3 (Men).

# **TOURNAMENT FORMAT - MEN'S DIVISION 3**

The Men's Division 1 Tournament for each division will consist of the remainder of the regular season double round-robin schedule. These "pool play" games and playoff matches are best 2 of 3 sets to 25, with the third set to 15. No point cap in any sets. The third set is played only if it is a deciding set. After pool play the regular season champion will be determined. The top two seeds will advance to the MEN'S DIVISION 3 SEMIFINALS, while the 3rd through 6th seeds will advance to the MEN'S DIVISION 3 QUARTERFINALS based on their regular season (pool play) finish. The following tiebreaker criteria will be used for seeding teams into the playoffs:

- (a) Overall Season Match Record
- (b) Head to Head Match Record
- (c) Set Percentage (sets won/total sets played)
- (d) Coin Flip

The quarterfinal playoff round winners will advance to the MEN'S D3 SEMIFINALS while the quarterfinals losers will advance to the MEN'S DIVISION 3 CONSOLATION CHAMPIONSHIP. Most losing teams will officiate the next match on their court. The MEN'S DIVISION 3 WVC CHAMPIONSHIP MATCH will be played at 2:30 pm on Court 3.

Jewelry rule from USA Volleyball states: For adult competition, jewelry may be worn provided its nature does not present a concern for safety, e.g., extremely long necklaces and/or necklaces with large medallions, or large hoop earrings."
